#### **ELIGIBILITY:**

The competition is open to all artist 18 years or older living in MA working in watercolor.

Jurying will be done from Actual Work. **NO SLIDES OR JPGS.**

**SIZE RESTRICTION:** No framed piece larger than 32 x 40 inches.

#### **ENTRY PROCESS:**

Non-refundable fee of \$25 for up to 3 submissions. **Please make check payable to Gallery Seven** and bring it in with the work. Each entry **MUST** be accompanied by an **Entry Form**. Work **DOES NOT** need to be framed for the jurying process. Jurying will take place in **October 2010**, see dates below.

Sat. 3/26: Last day of the Show

Thurs. 3/31- Sat. 4/2: Pick up work between 11 a.m. - 5 p.m.

## **JURORS:**

The jurors will be **Nick Johnson and Kelli Costa** co-owners of Gallery Seven. Nick has also been an instructor at the New England School of Photography in Boston for the past 16 years and was the Director of the school's gallery for 13 years. Joining them will be guest juror **Bruce Davidson**. Bruce Davidson received formal training at the Art Institute of Boston studying illustration and design. He continued training at the DeCordova Museum School in Lincoln, MA. He is a self trained watercolorist who has lived in Boxborough since 1998. His watercolor paintings and limited edition prints hang in homes and businesses around the globe. Bruce teaches watercolor, acrylics and drawing and is leading a watercolor expedition to Argeles-sur-mer, France in Summer 2010. He was recently commissioned for wall and ceiling murals in the new Bolton Public Library and frequently assembles and leads teams to paint donated murals for sick children and seniors. - **No scratches, dents or chips on the frame**
- **Glass or plexi must be clean and scratch free**
- **There should be NO noticeable dirt, hair, smudges or other debris underneath the glass**
- **No Sawtooth Hangers or Sandwich/Clip Frames**
- **No colored Mats. White or Off White ONLY**
- **No Masking Tape. Art must be framed ARCHIVALLY with acid free backing materials, acid free mat etc.**

**WORK NOT SUITABLY FRAMED WILL NEED TO BE REFRAMED  
OR IT WILL BE REJECTED**

## **SALES:**

Exhibited work will be available for sale (unless the artist designates certain entries not for sale NFS). Gallery Seven will retain a commission of 40% on all sales that occur during the exhibit. The balance will be paid to the artist at the end of the show and will include a statement listing work(s) sold. Artist agrees to allow accepted work to remain with the exhibit until the close of show.

**LIABILITY:** Gallery Seven is not responsible for damage to work submitted, although care in handling can be assured. Works will be insured, for the artist's percentage of the retail price, for fire and theft while at Gallery Seven. Gallery Seven **WILL NOT** insure the work while in transit or if the work is not retrieved by the pick up dates listed above.
