Exhibition Dates: May 15 - June 19, 2010. Reception Date: May 22nd from 7-9 p.m.

ELIGIBILITY:

Open to **high school (grades 9-12)** art students in the following towns: Acton, Bedford, Bolton, Boxboro, Carlisle, Concord, Groton, Harvard, Hudson, Lancaster, Lexington, Lincoln, Littleton, Maynard, Stow, Sudbury, Wayland, Westford, Weston.

Any original 2D artwork including photography, painting, printmaking (all types), collages etc. SIZE RESTRICTION: No dimension longer than 30 inches. The largest piece allowed would be 30x30 inches.

ENTRY PROCESS:

Limit 2 entries per student. Jurying will be from **ACTUAL WORK**. Each entry **MUST** have an **Entry Form** attached. Drop off and Pick up work at Gallery Seven, dates and times are listed below. There is NO entry fee.

CALENDAR:

Thurs. 3/11 - Sat. 3/13: Work dropped off for judging between 11 a.m. - 5 p.m.

Thurs. 3/18 - Sat. 3/20: All work must be picked up between 11 a.m. - 5 p.m.

Wed. 3/24: Notification will be emailed

Thurs. 5/6 - Sat. 5/8: All accepted work must be dropped off framed and ready to hang between 11 a.m. - 5 p.m.

Sat. 5/15: Opening Reception from 7-9 p.m.

Sat. 6/19: Last day of the Exhibition

Thurs. 6/24-Sat. 6/26: Pick up work between 11 a.m. - 5 p.m

JURORS:

The jurors will be **Nick Johnson and Kelli Costa**, co-owners of Gallery Seven. Nick has also been an instructor at the New England School of Photography in Boston for the past 16 years and was the Director of the school's gallery for 13 years; **Paul Sarapas** who is a Media Arts instructor and Department Head of the Fine, Applied & Technical Arts at Lincoln-Sudbury Regional High School. Paul has been working in film, photography, and other forms of media since his teen age years and continues to exhibit his work throughout New England; and art teacher **John Flynn** who has been teaching Visual Arts at Maynard High School for over 12 years. **PLEASE KEEP IN MIND: For the jurying process, while all submissions are welcome, not all work will be selected to be in the show.**

ACCEPTED WORK:

PRESENTATION:

Selected works need to be suitably framed, firmly wired and ready to hang, **NO SAWTOOTH HANGERS OR SANDWICH/CLIP FRAMES**. If a piece has mat board it must be white or off white, **NO COLORED MATS**. We know that custom framing can be expensive. Ready made frames are frames that are sold as a complete kit with glass and mat board.

SALES:

Exhibited work will be available for sale (unless the artist designates certain entries not for sale NFS). The price for each framed piece is entirely up to each artist to decide. Gallery Seven will retain a commission of 35% on all sales that occur during the exhibit. The balance will be given to the artist at the end of the show. Artist agrees to allow accepted work to remain with the exhibit until the close of show.

INSURANCE:

Gallery Seven is not responsible for damage to work submitted, although care in handling can be assured. Works will be insured, for the artist's percentage of the retail price, for fire and theft while at Gallery Seven. Gallery Seven will not insure the work while in transit.
